Dear Mr. Johnson:

On September 28, 1983, we met to discuss the above-captioned case at the fourth step of the contractual grievance procedure set forth in the 1981 National Agreement.

The question raised in this grievance is whether management properly denied the grievant's request for a special inspection under Sections 271 and 272 of the M-39 Handbook.

After further review of this matter, we mutually agreed that no national interpretive issue is fairly presented in the particulars evidenced in this case. Whether or not the carrier's request for a special inspection was properly denied is a factual situation and is suitable for regional determination. However, if the carrier's restriction is only the fact that he is limited to 8 hours of duty, and no other limitation exists which could distort a proper evaluation, the grievant may qualify for a special inspection.

Accordingly, as we further agreed, this case is hereby remanded to the parties at Step 3 for further processing, if necessary.

Please sign and return the enclosed copy of this letter as your acknowledgment of agreement to remand this case.

Time limits were extended by mutual consent.
