Dear Mr. Romero:

This is to confirm the disposition of the subject Step 3 grievance appeal which was recently discussed with your representative, Mr. Pete Goodman.

Based on information presented and contained in the grievance file, the grievance is denied. In this case, the employees in question were voluntarily reassigned from clerk craft to the carrier craft. Since there was no excessing from the installation, separation of all casuals is clearly not required by the National Agreement.

The time limit for processing at Step 3 was extended by mutual consent.

In our judgement, the grievance does not involve any interpretive issue(s) pertaining to the National Agreement or any supplement thereto which may be of general application. Unless the union believes otherwise, the case may be appealed directly to regional arbitration in accordance with the provisions of Article 15 of the National Agreement.

ND-25/89 Class Action

FACT: On 9/7/89, the Union learned that fourteen (14) Clerk Craft employees would be excessed to the Letter Carrier Craft. \*-Dart remanded on 9-19-89.

UNION POSITION: Background

In mid-July, we received a letter notifying us that 200 Clerks would be notified that they were excess to the needs of the Installation and that full-time vacancies in the Carrier Craft would be with held from posting. Ex-VP Conners was contacted and we were informed that a National Level case was filed on this matter.

On August 25 - Posting #R-89-01 was posted to the Clerk Craft - No copy to the NALC.

On September 5 - Change of Assignment Notice R-89-01 was received.

On August 31 and continuing - Personnel Notices indicate that Casual Clerks are still being hired.

Following the remand by the D.A.R.T., a grievance was initiated and the Step 2 response from Primo Marquez is enclosed.

As you can see, management is taking the position now that these Clerks are not excess to the needs of the Installation.

CORRECTIVE ACTION REQUESTED:

The 14 senior Letter Carrier PTF's be converted to full-time regular positions.

Dear Mr. Walker:

I am in receipt of your grievance No. ND25/89 in reference to the assignment of 14 employees from the clerk craft to the city letter carrier craft in the City of Dallas.

The employees assigned to the clerk craft were employees who volunteered for reassignment from the clerk craft to the letter carrier craft. The employees were reassigned in accordance with Handbook EL-311, Section 261.311(b).

Since this is a voluntary reassignment of employees from the clerk craft to the carrier craft, the excessing of all casual employees was not necessary. This would only apply in the event clerk craft employees were being excessed to the needs of the installation in accordance with Article XII of the National Agreement.

For the reasons cited above, your grievance is denied. The remedy requested in the grievance will not be implemented.

I apologize for the delay in responding to your grievance. If I can provide further information on this matter, please do not hesitate to call me.

The Dallas Post Office has experienced many changes in our mail processing activity during the past two years. Today we find that we process much more of our mail on automated and mechanized equipment than ever before. Having forseen this eventuality, we have been working with manual distribution clerks for the past two years in an attempt to reduce the number of manual employees by a significant number, and thereby eliminate the need for excessing anyone from the Dallas Post Office. While our efforts have met with some success, I regret to say that the results have not reached a level that would eliminate the need for any excessing. We currently have approximately two hundred (200) excess full-time, PS-5 manual clerks in the Dallas Post Office. You have been identified as one of the two hundred (200) junior manual clerks in the Dallas Post Office.

You are hereby notified that within sixty (60) days of the date of this letter it is proposed to declare you as being excess to the needs of the Dallas Post Office as a PS-5 clerk, and reassign you to one of the positions listed below:

- A. Reassign you to a job at your same salary level, in a different craft (probably city carrier) in the Dallas Post Office.
- B. Reassign you to another office within a hundred mile radius of the Dallas Post Office, in an assignment at your same salary level. This assignment could be to your same craft or to another craft.
- C. Assign you to a lower level position (possibly Mail Processor or Mail Handler) in the Dallas Post Office.
- 0. Assign you to a lower level position in another installation (possibly Mail Handler at the Bulk Mail Center).

Employees involuntarily reassigned under the above conditions will have retreat rights to their salary level, craft, and installation; provided they make application for retreat rights at the time of their reassignment and exercise the first available opportunity to return to their salary level, craft, and installation. Failure to exercise retreat rights at the first opportunity will cancel such retreat rights.

You will be given further written notice prior to your actual reassignment as described above. Although affected employees may not be completely satisfied with the impact and the move required, we hope that we have given you full information of your options and rights as an
