On June 5, 1996, I met with your representative to discuss the above-captioned grievance at the fourth step of our contractual grievance procedure.

The issue in this grievance is whether the Postal Service violates the National Agreement by requiring employees to wear their identification badge with their social security number exposed.

During our discussion, we mutually agreed that the following would represent a full settlement of this case:

Employees may request new identification badges in accordance with the procedures outlined in Postal Bulletin 21485, dated November 15, 1984.

Please sign and return the enclosed copy of this decision as your acknowledgment of agreement to settle this case in its entirety.

A new version of Forms 4098 BK and 4098 FR, Employee Identification, is now available at the supply centers. This version calls for the employee's social security account number to be placed on the reverse side of the form as Employee Identification Number. Placing the number there affords agreater measure of privacy.

### Form BK

Order the new version on the next scheduled wdering date. Use Form 7380, Requisition for Suplies, and be sure to request both Form 4098 BK and Form 4098 FR. This is necessary because the form is composed of two parts, each of which must be ordered to complete the process.

Upon receipt, destroy all stock of previous vernons of the form. Employees who have been asned previous versions may request the new one their option. Requests are to be honored and nocessed as soon as practicable.

The notice on page 9 should be posted for one accounting period for all employees to see.


## Reader's Digest Association Mailing
