After reviewing this matter, we mutually agreed that no national interpretive issue is fairly presented in these cases.


Accordingly, we agreed to remand these cases to the parties at Step 3 for further processing or to be scheduled for arbitration, as appropriate, with the following understanding:

Claims for over-payment regarding the promotion pay settlement will be processed in accordance with Article 28 of the National Agreement and Section 437 of the ELM.


Please sign and return the enclosed copy of this decision as your acknowledgment of agreement to remand these cases and remove them from the pending arbitration listing.
