

In accordance with the May 24, 2022, Memorandum of Understanding *Re: City Delivery Staffing Adjustment – Hiring Part-Time Flexible City Letter Carriers (M-01986)*, the parties have agreed to add the following installations in which the Postal Service will convert all city carrier assistants to part-time flexible (PTF) career status. Additionally, after these conversions are completed, the Postal Service will hire PTF city letter carriers in these installations in order to reach and maintain the number of PTF city letter carriers on the rolls as indicated for each installation.
